

Thank you to the members, leaders, advisors, and community folks who helped make the CTA-AE Fall Event a huge success!




The weekend in numbers:



State Council Representative

CTA's top policy-making body is the State Council of Education. Meeting four times a year, the council's nearly 800 delegates elect the three state-level CTA officers and the CTA Board of Directors. Council also sets forth CTA policy, develops legislation, and makes recommendations in general elections. CTA-AE State Council Representatives attend all CTA State Council meetings as representatives of Aspiring Educators.

November 13, 2024	Deadline for nominations, verify eligibility	
November 14, 2024	Email with ballot and candidate bio sketches. Voting begins on Election Buddy.	
November 20, 2024	Voting closes on Election Buddy at 11:59pm.
